 It investigates: Recruitment and use of children during armed conflict committed by Farc-EP and armed forces. This is the only SJP case that specifically deals with violence committed against children during armed conflict, among them, enforced disappearance, sexual violence and gender-based violence.



Type of actor: Farc-EP and armed forces.

Open since September 13, 2022 Prioritized period: 1996 - 2016



It investigates: Crimes committed by Farc-EP, members of armed forces, other State agents, or third-party civilians against Ethnic Peoples, collective subjects of rights or against Ethnic Territories, that are not being investigated in other SJP cases.



Type of actor: Farc-EP and State agents.

#### General data\*:

1.350.181 victims of Ethnic Peoples have been established by the SJP.

The most documented crimes in this judicial process are enforced displacement, murder, and enforced disappearance.

It investigates: Enforced abortions, enforced sterilization, sanctions for denying sexual requirements, rape, sexual slavery, denying the exercise of maternity, enforced displacement, enforced disappearance, and other cruel treatments.



Type of actor: Farc-EP and armed forces.

#### General data\*:

More than 30,000 children, adolescents, women, men, and LGBTQ+ population were subjects of these crimes between 1957 and 2016.

89% were women. 35%

of them suffered these types of violence when they were children or adolescents.

# Facts found during the investigation

Crimes expressed under the logic of armed organizations' violence, the power that magnifies the gender-based violence and the dominant relations surrounding gender

Through 11 macro-cases, the SJP investigates, judges and sanctions those found most responsible for serious crimes committed during the armed conflict in Colombia. Here the victims actively participate, the defendants bring truth about the facts committed and are held accountable.



## General data\*:

21.396 victims of hostage-taking.

4.056 accredited victims to participate in the judicial process.

8% of the victims were also disappeared.

795 victims have made observations about what 402 Farc-EP defendants have said before the SJP.

14 years was the most prolonged time that a victim was held in captivity.

4 preliminary indictments have been emitted, in which **32 Farc-EP defendants** were found most responsible for war crimes and crimes against humanity:

7 former members of the Farc-EP's last Secretariat. 10 former members of the Farc-EP's Joint Central Command. 8 former members of the Farc-EP's Western Bloc. 7 former members of the Farc-EP's Northwestern Bloc.

The SJP will impose indictments to those most responsible of 4 other regional Farc-EP structures.

Open since July 10, 2018 Prioritized period: 1990 - 2016



It investigates: Killings, enforced disappearance, enforced displacement, conscripting or enlisting children, unlawful confinement, use of antipersonnel mines, attacks against civilian property and the destruction of nature, territory and environment.



Type of actor: Farc-EP and State agents.

111.341 accredited victims\*

to participate in the judicial process. 148 individual victims. 13 collective subjects.

# 6 macro-criminal

patterns, identified by the SJP, caused serious, differentiated, and disproportionate damages.

They were indicted, among others, with crimes against Nature, Territory, places of worship and with gender-based violence.



Killings and enforced disappearances presented as combat casualties by State agents.



**Open since** July 12, 2018

**Prioritized period:** It varies in each of the six regional subcases, but they are all framed between 2002 and 2008



It investigates: The war crime of murder and the crimes against humanity of killings and enforced disappearances.



Type of actor: State agent members and non-members of armed forces, and third-party civilians.

### General data\*:

At least **6.402** persons were killed, and some of them disappeared, to be presented as false combat casualties by State agents and armed forces members, between 2002 and 2008.

3.468 victims are accredited to participate in the judicial process.

838 hearings with defendants before the SJP.

# 107 defendants

have been indicted and found most responsible for war crimes and crimes against humanity.

It investigates: Acts of violence, murder, enforced disappearance, torture, enforced displacement, sexual violence, serious deprivations of liberty, prohibited means and methods of warfare, environmental damages, and damages of civilian property.



Type of actor: Farc-EP and State agents.

48.352 victims

are accredited to participate in the judicial process. Of which 477 are accredited individually and 120 are accredited as collective subjects.

It investigates: Murder, enforced disappearance, use of antipersonnel mines, gender-based violence, enforced displacement, torture, taking of hostages, conscripting or enlisting children, attacks against civilians.



Type of actor: Farc-EP and State agents

#### General data\*:

180,000 victims

are accredited to participate in the judicial process. 379 of them individually and 129 as collective subjects.

Among these victims, there are:

45 indigenous peoples, 67 community councils, and 8 victims' organizations.

It has also been accredited the ancestral and collective Nasa territory of Cxhab Wala Kiwe (Territory of the Great People), Also, in 2023, the Cauca River was accredited by the SJP as a victim of armed conflict.

## 10 defendants of the Farc-EP were indicted with

14 war crimes and crimes against humanity of attacks against civilians, use of antipersonnel mines, killings and enforced disappearances of Ethnic and peasant community leaders, as well for the persecution, recruitment and use of children during armed conflict.

Open since February 26, 2019 Prioritized period: 1984 - 2016



It investigates: Crimes against life, liberty and security, deprivation of physical, sexual and psychological integrity, and other violations of Human Rights and infractions against International Humanitarian Law.



Type of actor: State agent members and non-members of armed forces, and third-party

#### General data\*:

498 victims

are accredited to participate in the judicial process. Which include 237 women, 257 men, and 4 collective subjects: the Patriotic Union political party, the Communist Party, and the Sintramienergética and Cenaprov workers unions.

5.733 persons were killed or disappeared in attacks committed against militants of the Unión Patriótica political party, between 1984 and 2016.

The most affected regions were the Ariari-Guavabero. Magdalena Medio, Urabá, Cundinamarca-Sumapaz, and Tolima.
