Guidelines for the publication of contributions to the edited volume:

"Armed conflict, the environment, and territory: reflections on the territorial and environmental approach at the Special Jurisdiction for Peace"

GENERAL REMARKS

- 1. Contributions to the edited volume shall be original work or substantially updated versions of earlier publications. <u>Published papers or book chapters</u> <u>(including translations thereof) will not be accepted.</u>
- 2. The edited volume will be published as a bilingual book in Spanish and English. Nevertheless, at least 80% of the articles will be published in Spanish. Proposals submitted in French or Portuguese may be considered exceptionally for publication based upon their originality and the interest that they generate. In that case, the SJP will be responsible for their translation into Spanish. Authors who submit proposals in languages other than Spanish shall provide an additional 2-page abstract in Spanish.
- 3. Submissions must be presented in Word format.
- 4. Abstracts shall observe a 1,000-word limit (footnotes included) and shall abide by the detailed content of the call for submissions.
- 5. The final version of the articles submitted shall have a length of between 5,000 and 10,000 words (footnotes included).
- 6. Longer articles may only be accepted on an exceptional basis.

The contributions to the edited volume shall observe an amended version of the latest edition of the **Notes-Bibliography References of the Chicago Manual of Style** (<u>https://www.chicagomanualofstyle.org/tools_citationguide/citation-guide-1.html</u>), composed of footnotes on each page and a list of references or bibliography at the end of the article. The information must be presented in accordance with that format and



observing its punctuation rules (commas, periods, colons, semi-colons, parenthesis, etc.). The list of references must include all the works that were cited within the text (in a 1:1 ratio), they must be numbered, and they must be presented in alphabetical order. It is essential to include the full names of the authors and/or editors of each listed work.

Format and preparation of the proposals:

The authors must observe the following guidelines in order to consider their proposals for publication:

- Articles must be written in Word format, font Times New Roman, size 12, with 1 ½ spacing. Pages must be letter size and they must be numbered. Margins must be 2,5 cm on all sides.
- Footnotes must be written in font Times New Roman, size 10, with single spacing.
- Articles must be between 5,000 and 10,000 words in total, including abstracts, keywords, footnotes, and lists of references.
- Articles must contain an abstract in Spanish, no longer than 1,000 words, and its respective translation either into English or Spanish. The title of the article may be presented in both languages.
- Articles must contain between three and six keywords in English and in Spanish. The keywords must reflect the content of the document and, thus, they must refer to the specific topics of the article, highlighting the areas of knowledge to which it pertains and the main ideas discussed.
- Articles must be written in an academic language that is accessible to audiences from different backgrounds.
- Authors must provide their professional information (i.e. academic degrees, ٠ institutional affiliation, number of ORCID, investigation groups or lines - if applicable –, their two latest publications, and their email address) in an annex.
- That same annex must detail the origins of the article. Should it be the result of an investigation, the information regarding the project to which it belongs and the name of the financing institution – if applicable – must be included.
- Should cited works possess a DOI identification number, this must be included • in the list of references.

Editing rules:

- The first time an acronym or abbreviation is employed, it must be written in all caps, between parenthesis, and next to the complete formulation. From that point onwards, only the acronym or abbreviation must be employed.
- Citations that are four lines or longer must be presented in long citation format, • within quotation marks, with single spacing, font size 11, and reduced margins.
- Charts, graphics, illustrations, photographs, and maps must be referenced and explained in the text. They must also be entitled and numbered sequentially, as well as accompanied by their respective footers and source(s). They must be



placed immediately after the paragraph in which they are announced. Images must be submitted in high resolution and digital format (.jgp, .tiff 300, and .dpi 240). The Commission on Territory and the Environment of the SJP cannot guarantee the publication of those images that fail to meet this standard. It is the author's responsibility to submit permission for the publication of the images that may be subject to copyright.

- Footnotes must be written in digits instead of Roman numerals.
- The complete references of all the works cited in the article, which correspond to those contained in the footnotes, must be arranged in alphabetical order in the list of references or bibliography.

The following abbreviations will illustrate the citation format in footnotes (FN) abbreviated notes (NA) and the list of references or bibliography (B):

Books or book chapters:

<u>Single author</u>

Four authors or more

Introductions, prefaces or presentations (other than the leading author)

Journal or magazine articles and theses

AN Last Name(s), "(shortented) Title of the thesis", pages consulted. Example: Bermúdez, "Sinergia y aprendizaje", 20.

B Last Name(s), Name "Title of the thesis". Undergraduate/master's/doctoral thesis, Institution, year).

Example: Bermúdez, Martha, "Sinergia y aprendizaje. Un modelo escolar de contacto entre grupos y aprendizaje a través del servicio". Master's thesis, Universidad de los Andes, 2009.

Interviews and personal communications

Regardless of the medium employed for the interviews or personal communications – radio, audiovisual materials, face to face meetings, online discussions or phone conversations –, the citation will begin with the name of the person/s interviewed or from whom the communication was received. The interviewer or recipient will be mentioned subsequently if available.

It is not advisable to include unpublished interview in the list of references. In that case, the use of footnotes would suffice:

Reference should be made to a collection of documents (pages) or to an individual or organization, whose specific location should be available online.

<u>Blogs</u>

FN Name Last Name (or Pseudonym), "Title of the entry or comment", *Blog title* (*blog*), day month year, url.

Last Name, "(shortened) Title of the entry or comment", <mark>pages consulted</mark>. Example: Torres, "Ejercicios de ortografía".

B Last Name, Name (or Pseudonym). "Title of the entry or comment". *Blog title (blog)*, day month year, url.

Use of Ibíd. o Ídem.

Ibíd

The expression "Ibíd." Should be used in the footnote when different pages of the same work are cited twice or more consecutively, indicating the number of the referenced page. Example: Ibíd., 64.







Ídem

The expression "Ídem" should be used in footnotes when the author intends to signal that the material being referenced, including the exact page, is identical to the reference immediately before it.

Note: Under no circumstances should the expression "op. cit." be used.

Format and preparation of the reviews:

The reviews must respect the following guidelines:

- Reviews must be submitted to the following email address: <u>publicacion.territorial@jep.gov.co</u>
- Reviews must be written in Word format, font Times New Roman, size 12, with 1 ½ spacing, pages must be letter size and numbered, with 2,5 cm margins on all sides.
- The word limit for the reviews is 1,000 words.
- The reviews must include all the information of the reviewed text (i.e. author, title, date, city, editorial, and number of pages).
- The reviews must include all the academic information of the autor: academic degrees, current place of employment or education, number of ORCID, research group to which they belong, and email address.
- Beyond summarizing the contents of the document, it is expected that the reviews should incorporate a critical and analytical perspective along the same lines proposed for the publication.
